Message from the Co-chairs



The 18th Annual Northwestern Cardiovascular Young Investigators' Forum (NCYIF) was a tremendous success as we welcomed 34 Young Investigators from around the United States. The Young Investigators' Forum took place September 28–30, 2023, in downtown Chicago at the Omni Chicago Hotel.

At this year's forum, there were 9 Expert Faculty Judge Mentors, including specialists in cardiology, endocrinology, and nephrology; and 34 early career investigators, who successfully presented exciting late-breaking science. We were incredibly impressed with the high-quality, high-impact research that was presented. The breadth and diversity of science covered a range of topics, including cardiovascular genomics, population health, and health disparities. Six research grant awards were provided in the Junior Faculty and Fellows categories. The first place clinical research award for the Fellows category went to Jelani Grant, MD; and the first place award for the Junior Faculty category went to Kevin Southerland, MD. Also in the Junior Faculty category, Dan "Amanda" Tong, MD, PhD, was chosen for the Jeremiah Stamler Distinguished Young Investigator Research Award. These grants are awarded with the purpose of furthering research in cardiology.

In addition to the Young Investigator presentations, meeting highlights included the alumni dinner with former NCYIF awardees, Drs. Rohan Khera and Virginia Hahn, who shared the positive impact that NCYIF has had on their career development and the successes they have since experienced (as well as how they have overcome challenges). Networking with the expert faculty judges was a key focus for the attendees with structured and unstructured time. To augment the professional development aspects of NCYIF, a team of professional coaching experts from Listen Write Present returned to provide one-on-one presentation coaching sessions.

The participants identified several highlights of the 2023 forum. The feedback provided by the Expert Faculty Judges on the presentations and future directions, in addition to the mentorship during the Meet-the-Professor luncheons, was reported among the highest yield aspects of the meeting. Attendees also valued being able to meet and network with peers and near-peers. The program's success truly lies in the excellence, passion, and collegiality of the attendees.

On behalf of the NCYIF Faculty Judges, we would like to congratulate all of the participants on their accomplishments and wish them the very best for continued success in their future research and career endeavors.

CELEBRATING THE LEGACY OF

Jeremiah Stamler, MD



Dr. Jeremiah Stamler has left an ineffable legacy within cardiovascular research, pioneering many of the foundational axioms current cardiovascular research is built upon. He served as the founding chair of the Department of Preventive Medicine and Emeritus of Preventive Medicine at Northwestern Feinberg School of Medicine. Dr. Stamler is universally hailed as the "father of preventive cardiology." His research was pivotal in establishing hypertension, smoking, diabetes, hypercholesterolemia, and high-fat diets as cardiovascular risk factors. The INTERSALT Study established the connection between increased sodium intake and hypertension. His pursuit of research was truly lifelong as he published over 670 peer-reviewed papers and 22 books and monographs, was cited more than 56,000 times, and led an NIH-funded study investigating the connection between hypertension and the human metabolome.

The NCYIF first presented the Jeremiah Stamler Distinguished Young Investigator Research Award in 2005 to honor Dr. Stamler's tremendous influence on cardiovascular research and preventive medicine. The award is presented to junior faculty of basic science and of clinical research who demonstrate commitment to the pursuit of establishing innovative and foundational knowledge within cardiovascular health and preventive medicine.

The NCYIF will continue to honor the legacy Dr. Jeremiah Stamler has given the world of cardiovascular medicine and to memorialize his efforts by providing a platform that supports promising young investigators through mentorship, facilitation of collegial connections, and coaching to refine presentation and research defense skills, which all help promising early career scientists within cardiovascular research to exponentially increase the productivity of their research and publications.

Dan "Amanda" Tong, MD, PhD, is an assistant professor in the Department of Internal Medicine at UT Southwestern Medical Center and a member of its Division of Cardiology. She received her medical degree from the Tongji Medical College in China and her doctorate from the University of Western Ontario in Canada. She completed internal medicine residency training at the University of Iowa, followed by advanced training through a cardiology fellowship at UT Southwestern Medical Center. Certified by the American Board of Internal Medicine in Cardiovascular Medicine, she joined the UT Southwestern faculty in 2021.

As a physician-scientist, Dr. Tong's research and clinical interests are focused on cardiovascular conditions that are tightly associated with metabolic diseases, particularly heart failure with preserved ejection fraction and atrial fibrillation. Her investigations have resulted in 26 publications in peer-reviewed journals and contributions to one book chapter, and she has presented her findings at scientific conferences throughout the United States and around the world. Dr. Tong is active in several professional societies, including the American Heart Association and the American College of Cardiology.

Dr. Tong's interests outside of medicine include her family, cooking, and reading.






Presentation Skills Enhancement Workshop

To augment the professional development aspects of the NCYIF, 2023 participants had the opportunity to receive individual coaching sessions by a team of experts from Listen Write Present. Young investigators who participated in the one-on-one pre-program coaching sessions received expert advice and critique of their presentation and public speaking skills, and were given a copy of the book *Listen. Write. Present.*, which was written by the Listen Write Present team. In addition, the expert coaches provided participants with tips for effective navigation of expert Q&A and research defense.

Charge in Attendee Confidence




Following coaching and abstract presentations, average participant confidence in their ability to present scientific information to peers increased from


